

Conducting these types of analysis will assist the Department in identifying continuing steps in order to:

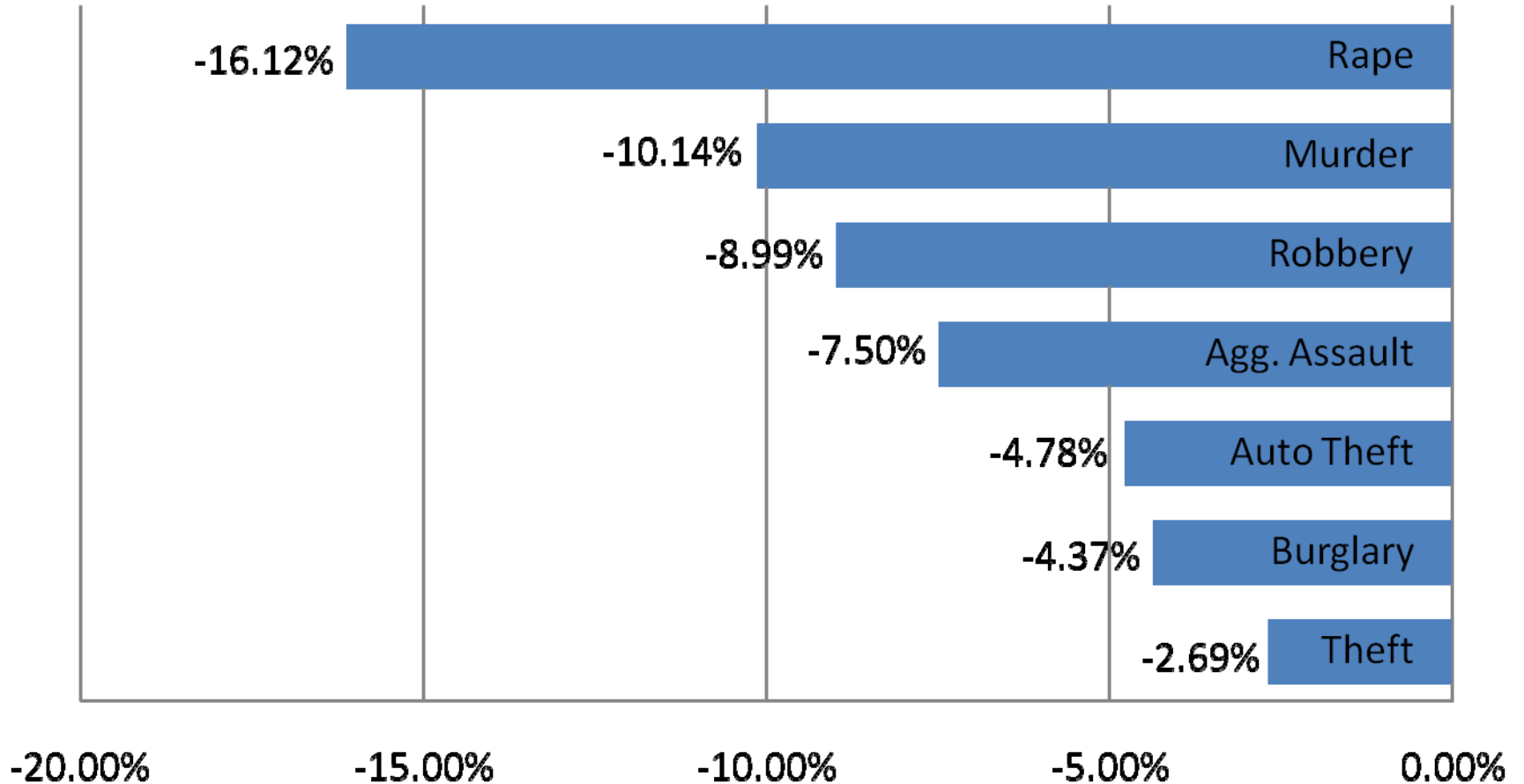
- Experience an unprecedented 9 years of overall crime reduction
- Make Dallas one of the 5 safest large cities by reducing the overall crime rate

# 2011 Crime Statistics

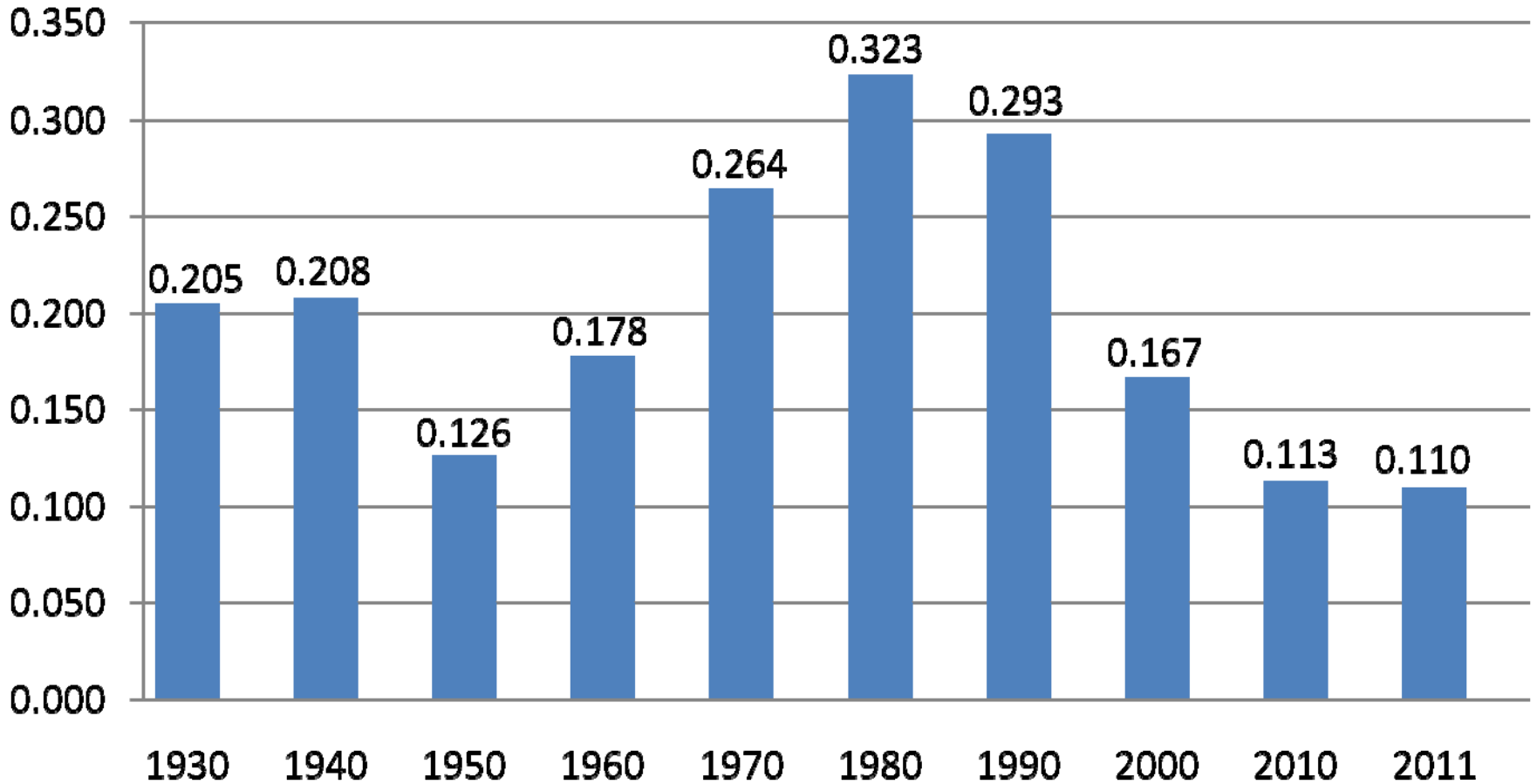
- Unprecedented 8th consecutive year of total crime reduction, YTD -4.14%
- 10th consecutive year of violent crime reduction, YTD -8.76%
- 3<sup>rd</sup> lowest murder rate in modern era
- Lowest per capita murder rate in 54 years (1957)
- Lowest number of actual murders in 44 years (1967)
- Total crime down 38.9% since 2003



# 2011 vs. 2010 Overall Major Crime Change

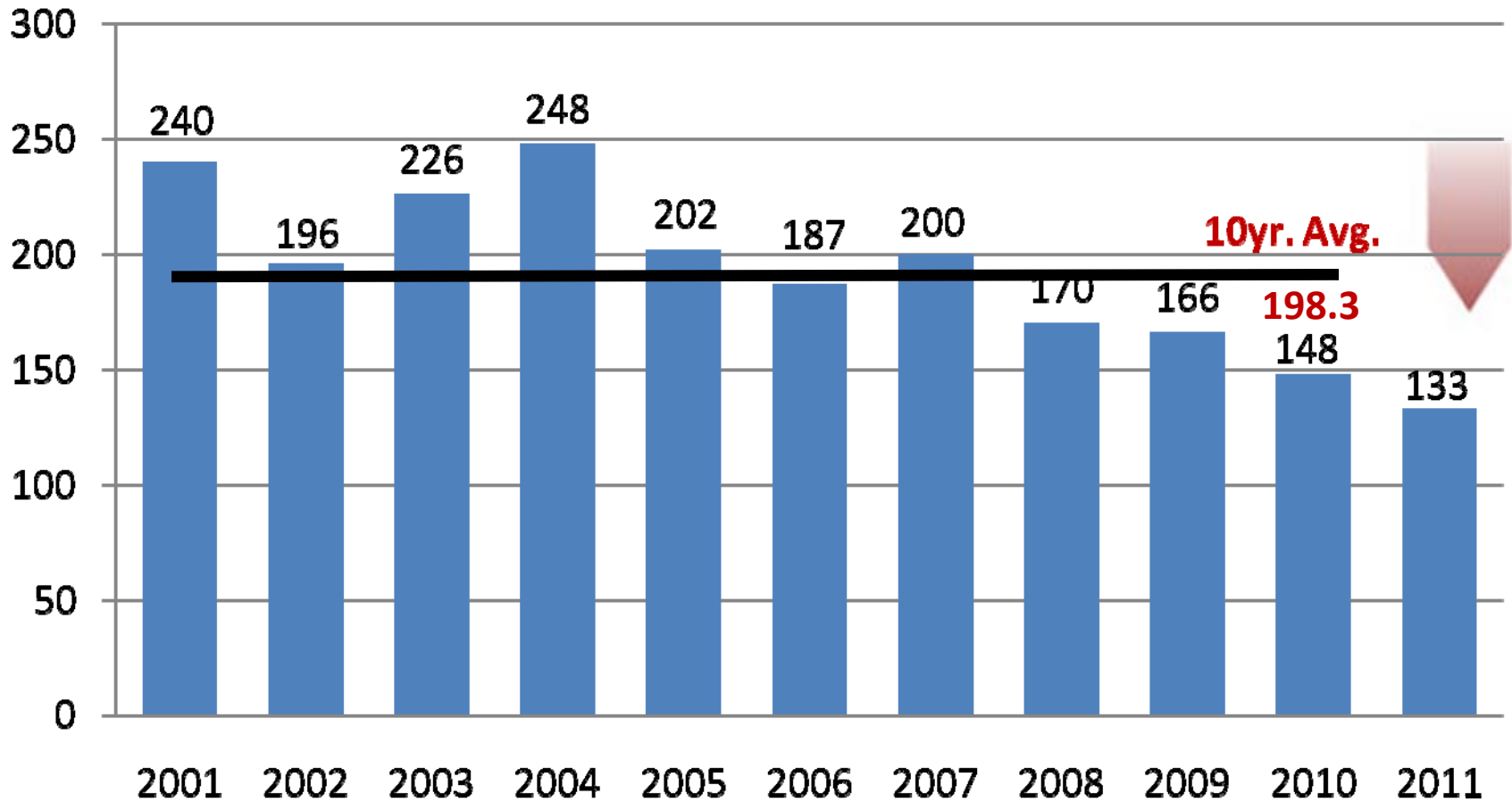


# Murders per 1000 (1930 – 2011)

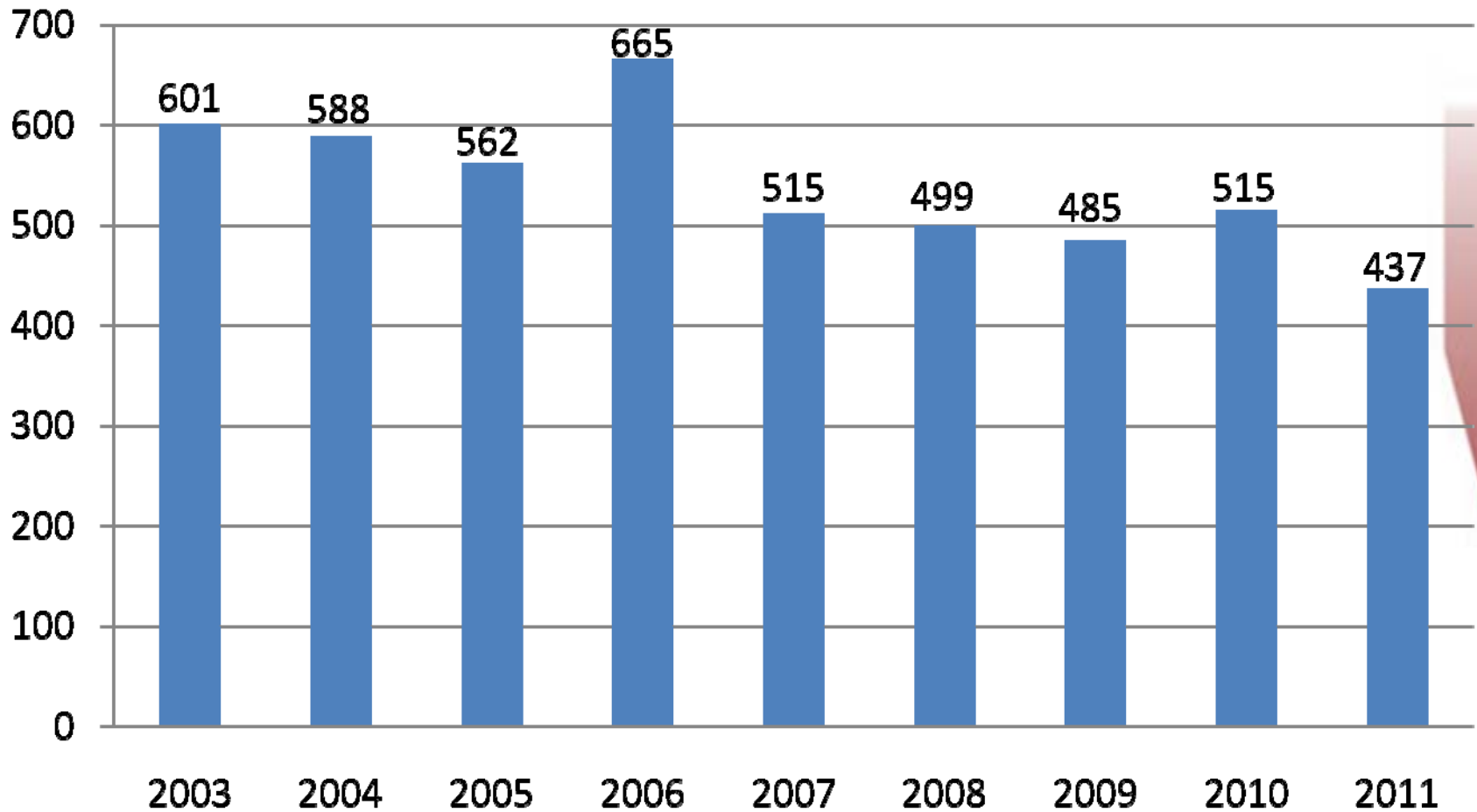

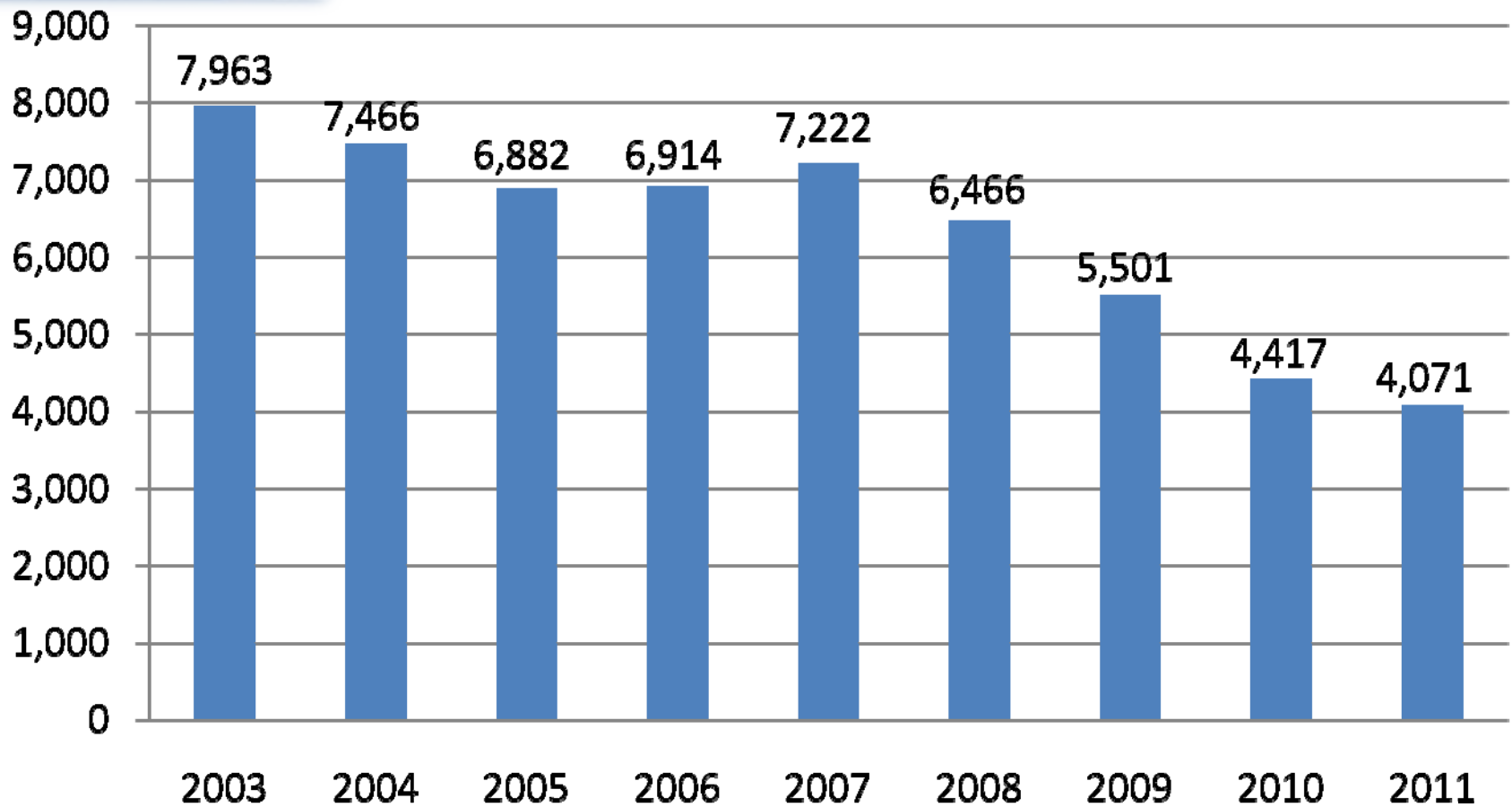

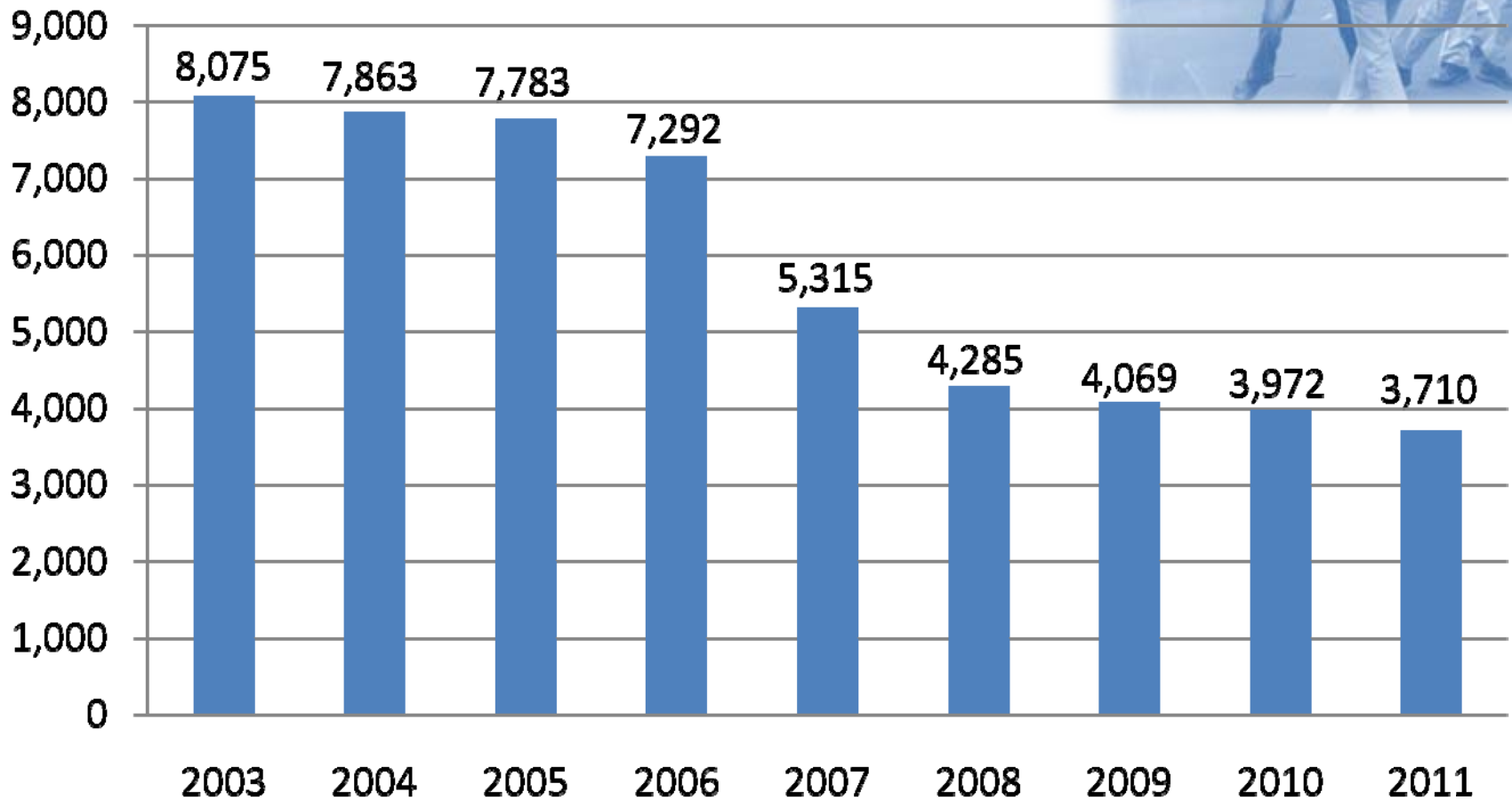




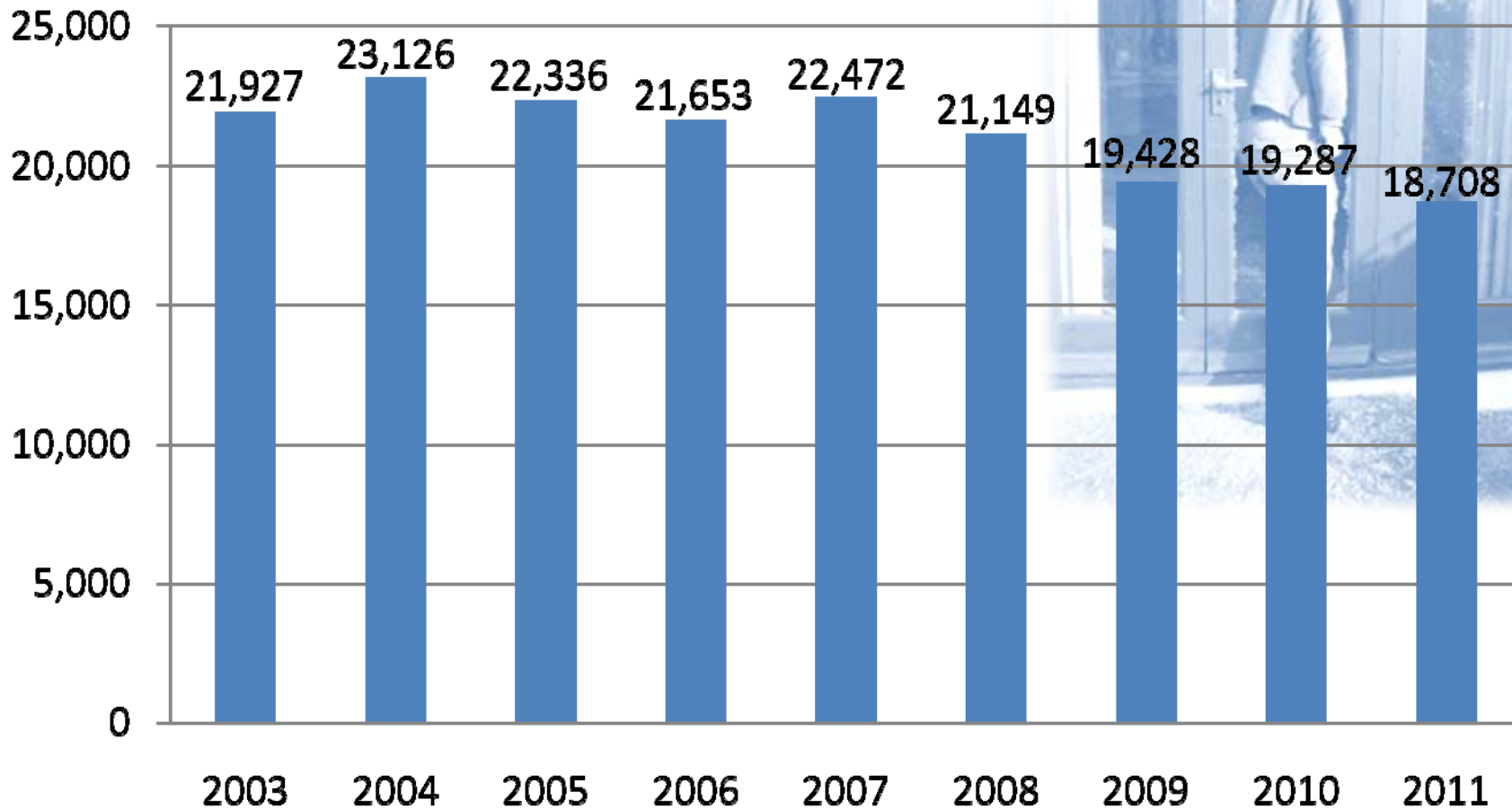
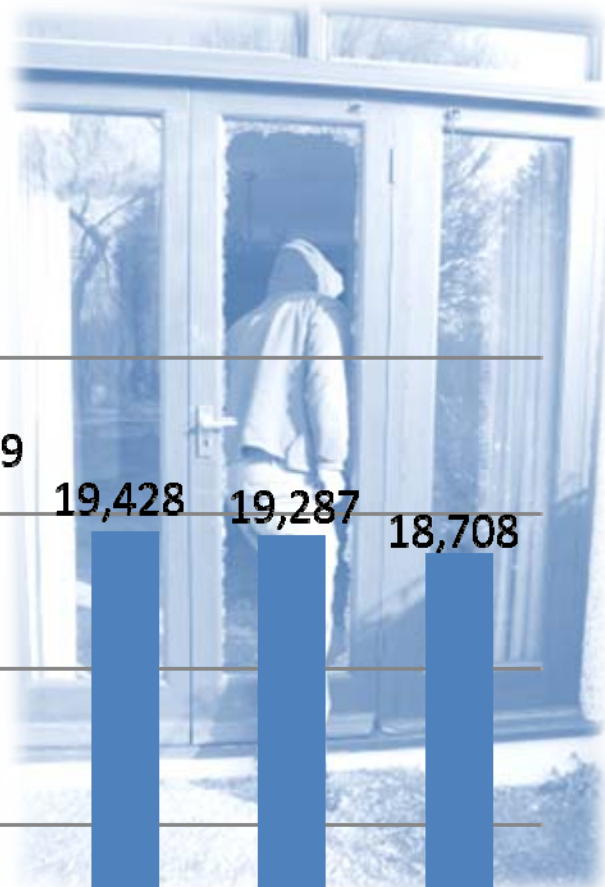
# Robbery 2003-2011



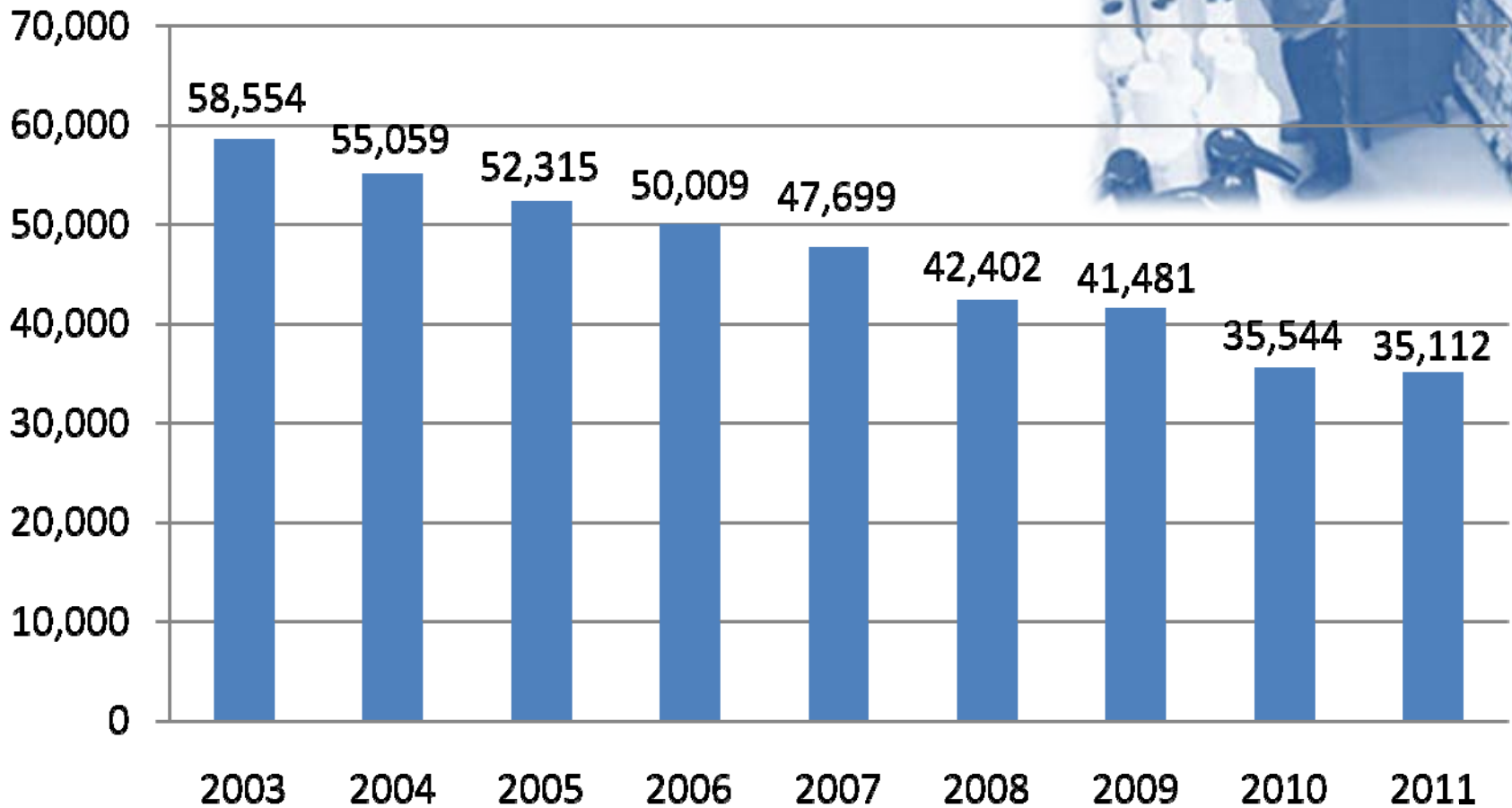
# Aggravated Assault 2003-2011



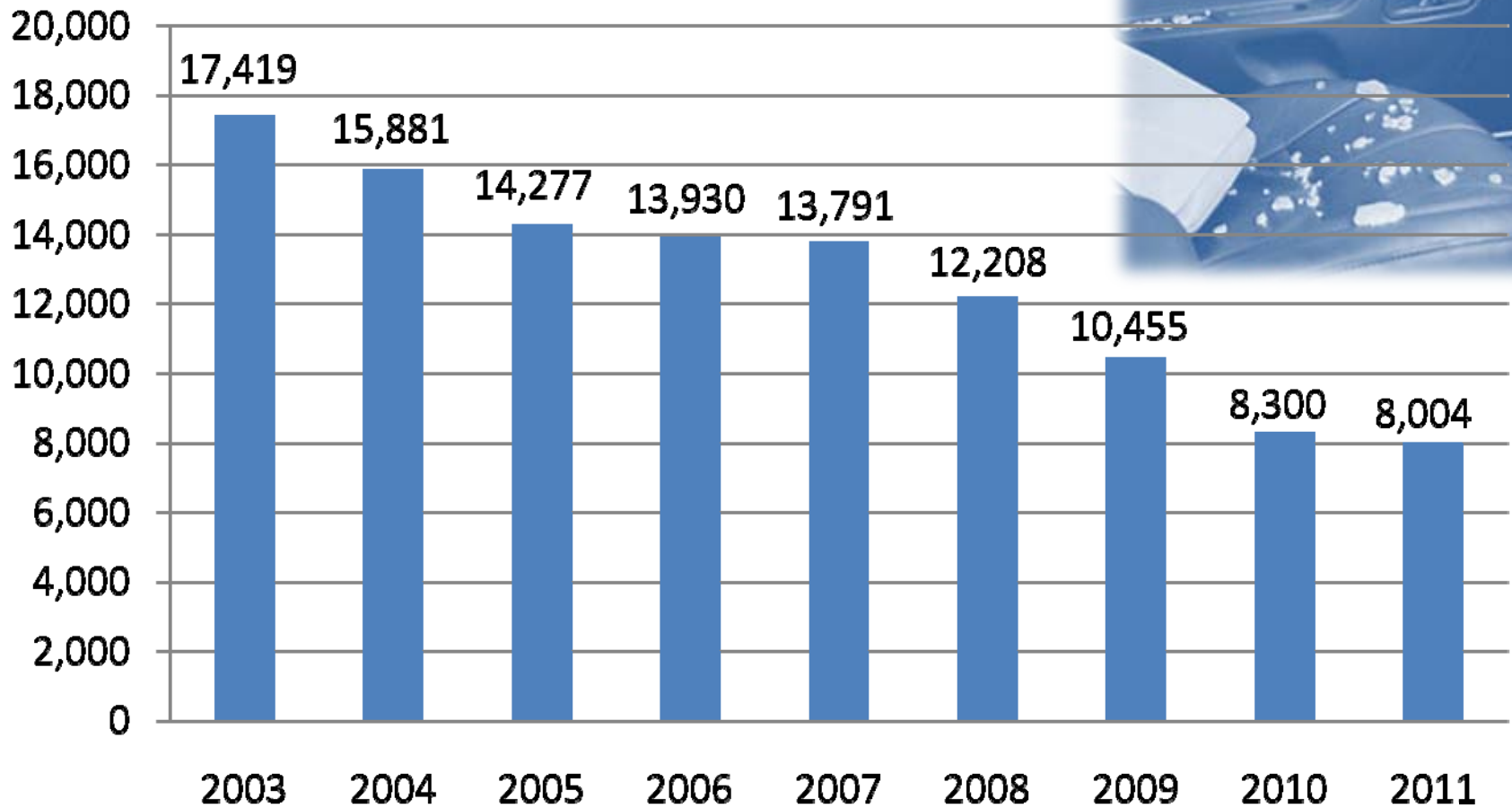
# Burglary 2003-2011



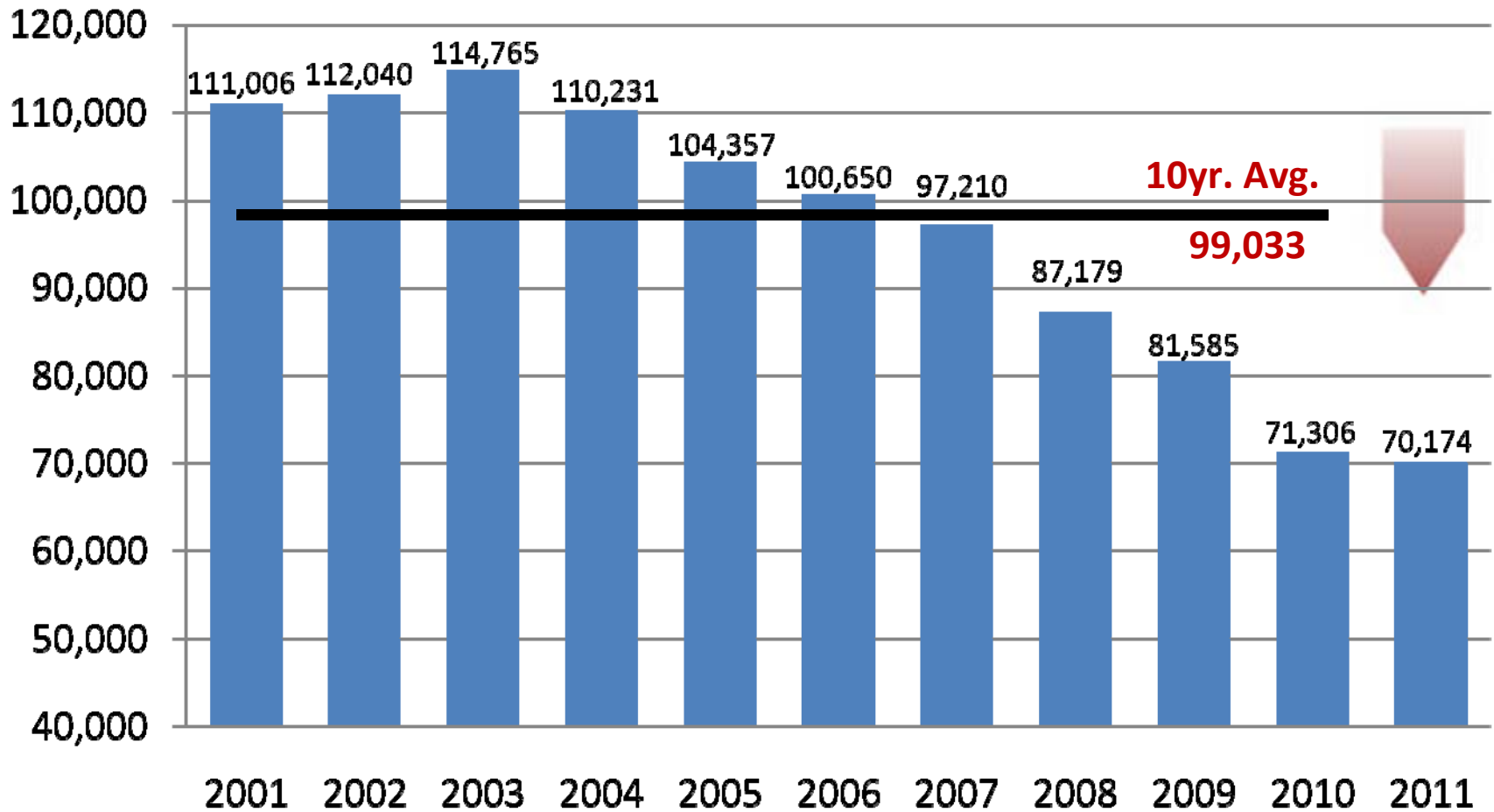

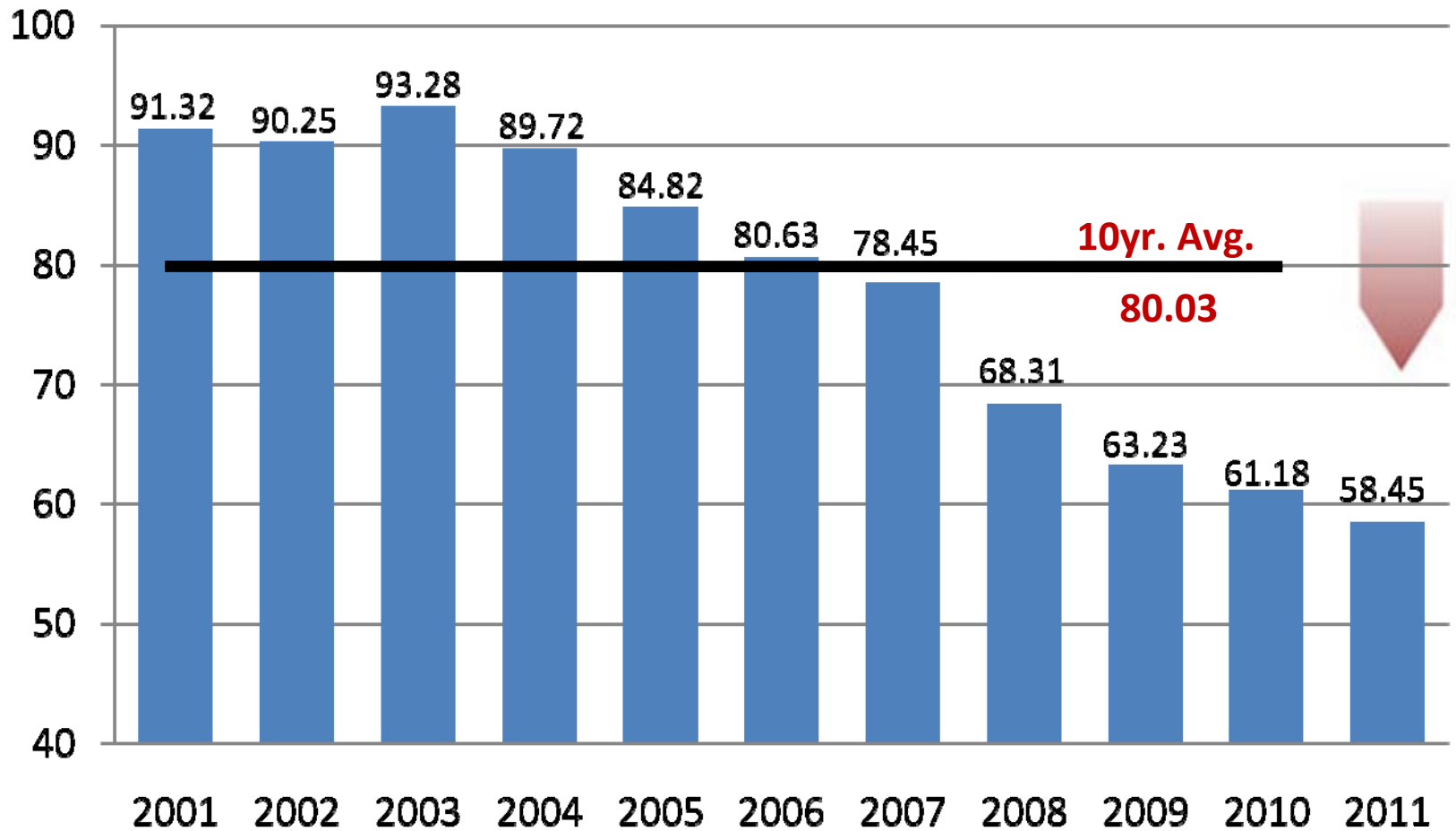
# Auto Theft 2003-2011



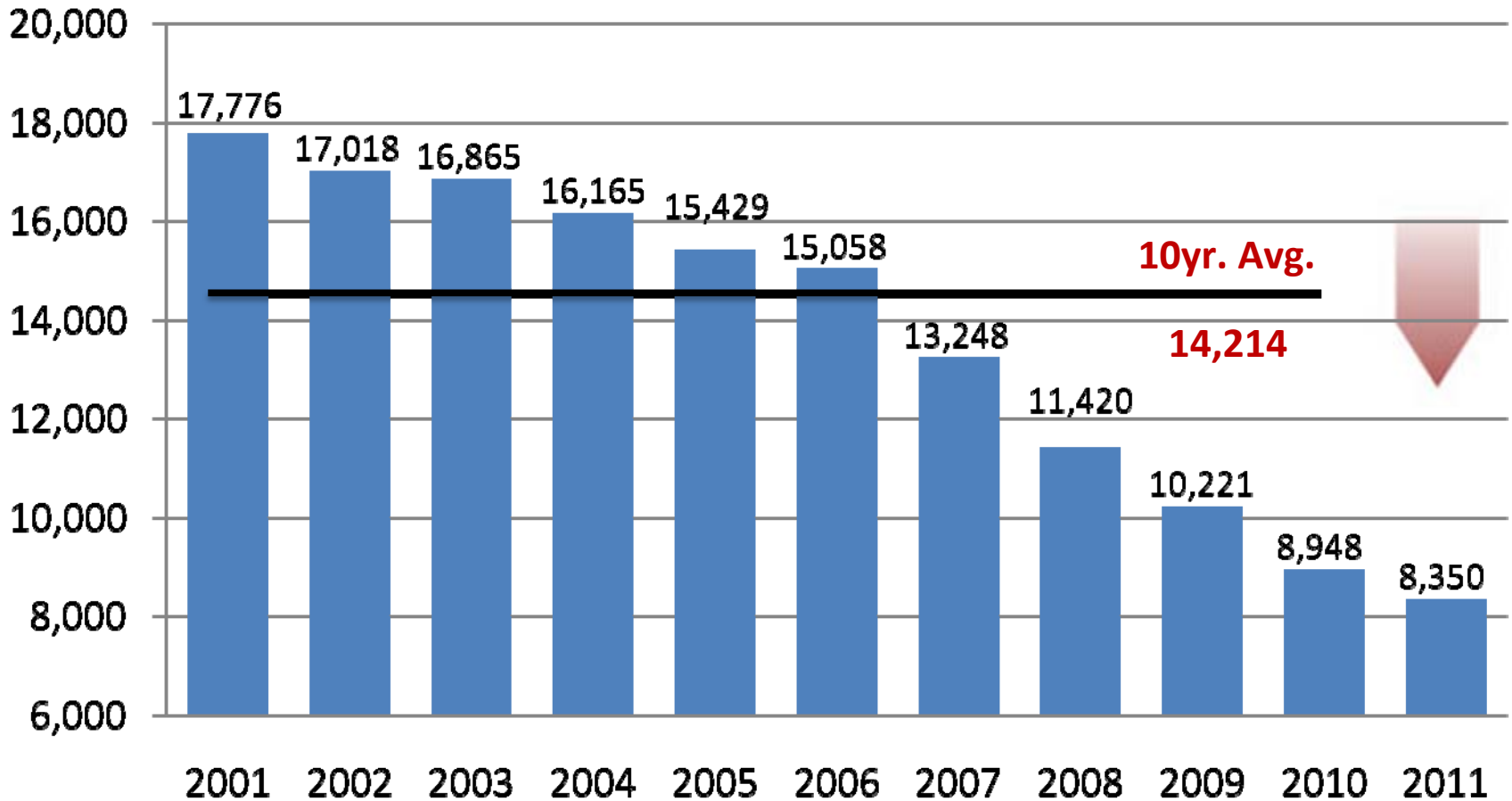
# Total Reported Crime 2001-2011



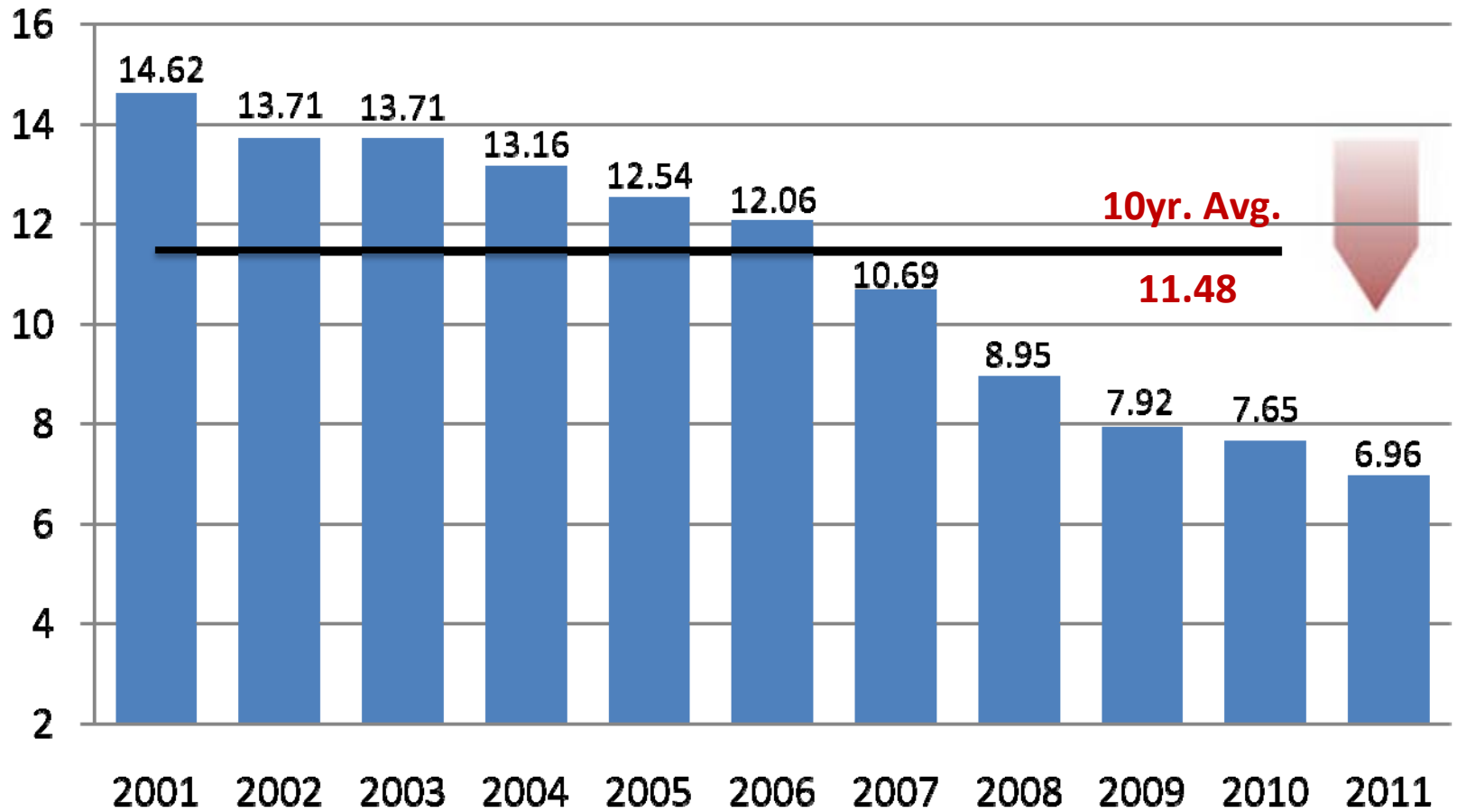
# Total Reported Crime Per Capita 2001-2011
